Family Equality Council is committed to making sure that LGBTQ parents and those who wish to form an LGBTQ family have clear access to a variety of family formation/expansion options, as well as resources to support them as they seek to become parents. The program team is working with prospective parents to educate and support them through their journey, family building organizations to help them feel prepared for our LGBTQ families, and employers who are hoping to develop LGBTQ family-friendly policies and benefits.
